#### 92. MAYOR'S ANNOUNCEMENTS

(a) Members had been informed that former Councillor Dave Cranham sadly passed away recently. Dave represented the former Brownsover North/Coton and Boughton Ward from 2006 to 2014 and then the Hillmorton Ward from 2016 to 2021.

Dave served on a number of Committees and Task Groups and was a regular member of Planning Committee, serving as Vice-Chair from 2010 to 2012.

Everyone present at the meeting stood in a moment's silence in memory of Dave.

(b) On Saturday 6 May the borough will be celebrating the coronation of King Charles III and will be represented at the coronation ceremony by the Lord Lieutenant of Warwickshire, Tim Cox.

Here in Rugby, many of our neighbourhoods would be holding street parties. The Council would be hosting its own off-street street party in Caldecott Park, and all of our residents were invited to join us. Everyone was asked to bring a picnic, blankets or chairs and enjoy a day of free, family entertainment in Rugby town centre. Entertainment would include a Punch and Judy show, a balloon modeller, juggler, stilt walkers and a living statue. There were additional activities and exhibitions being hosted by Rugby Art Gallery and Museum.

To mark His Majesty The King's Coronation, voluntary organisations across the country were getting together for The Big Help Out. A number of organisations would be attending a volunteer fair at the coronation picnic. Anyone attending would be able to find out about how they could support the valued work of Warwickshire CAVA, Girl Guiding, Rugby Sea Cadets, Royal Marine Cadets, Cruse, RNLI, and Myton Hospice.

The Mayor hoped everyone was looking forward to another memorable weekend, and invited all Members to join the celebrations and be a part of another chapter of our borough's proud history.
