1. EVENT AND MEETING ASSISTANT AT THE BENN HALL

Cabinet considered a report concerning a proposed additional post of Event and Meeting Assistant at the Benn Hall.

Recommendation of Cabinet

2. FINANCE AND PERFORMANCE MONITORING 2021/22 – QUARTER 2

Cabinet considered a report concerning the Council's financial and performance position as at the end of the second quarter of 2021/22.

Recommendation of Cabinet

Cabinet decided to recommend to Council that -

- (1) a supplementary General Fund revenue budget of £0.080m for 2021/22 for increased agency costs within Planning; to be financed through increased Planning income be approved;
- (2) a General Fund budget virement of £0.080m for 2021/22; to reduce expenditure budgets within services (as detailed in section 6) where savings have been identified and a corresponding reduction in the 2021/22 corporate savings target be approved; and
- (3) performance information in section 7 and Appendix 3 be noted.

1. UPDATE TO COUNCILLOR CODE OF CONDUCT

Audit and Ethics Committee considered a report concerning proposed amendments to Rugby Borough Council's Code of Conduct for Members based on the Local Government Association's Model Councillor Code of Conduct 2020.

The Committee considered the threshold for registration of gifts and hospitality as recommended by the LGA and agreed that this would be subject to further analysis.

Recommendation of Audit and Ethics Committee

Audit and Ethics Committee decided to recommend to Council that the LGA Code as amended and detailed within the report, be adopted.

Recommended that – the recommendation of Audit and Ethics Committee be approved.

Note: The Committee also debated the threshold for gifts and hospitality but did not consider this required an amended recommendation at this time.
