# Public Report of the Chief Officer - Leisure and Wellbeing

#### Summary

On 20 July 2021, Council referred a motion to a scrutiny committee in accordance with Council Standing Order 11.

The Committee is asked to consider the Motion and decide how it should be dealt with.

### **1. MOTION FROM COUNCIL**

On 20 July 2021, Council considered a motion submitted on notice by Cllr Rabin and seconded by Cllr Ms Watson-Merret as set out below.

"The Kings Fund recommends that local authorities should "ensure that parks are well maintained, and that anti-social behaviour does not act as a disincentive for people to enjoy the space and derive health benefits from it."

With regard to Newbold on Avon Quarry Park, the Borough Council has completed two actions in the last two years:

- 1. To place a Public Spaces Protection Order (PSPO) upon the site (March 2019)
- 2. To remove the viewing platform located adjacent to the disabled-user car park.

The area is unsuitable for wheelchair or disability access. The disabled-user car park provides access for cars. Beyond that, an able person would struggle to walk the paths – particularly after any wet weather.

Newbold Quarry Park is being wasted. Council is therefore requested to establish a suitable cross-party working group to assess the following matters:

- a) a hard surfaced, pathway around the perimeter of the lake, suitable for wheelchair access directly from the existing disabled-user parking area, with several bankside viewing areas.
- *b)* planning suitable interventions designed to increase access to green and open spaces for all members of our community, particularly disadvantaged groups.

- c) Improving the quality of those prominent green and open spaces that have received no improvements for a significant time such as Criss Cross Park, Brownsover.
- d) Funding which shall include third party funding for the above identified matters.
- e) Engage with local communities, disability charities and volunteer groups to achieve the above objectives.

The above activities will require a detailed knowledge of local needs, cultural contexts and attitudes, with clear objectives and strong targeting."

In accordance with Council Standing Order 11, the motion stood referred to Scrutiny Committee.

### 2. MOTION ON NOTICE PROCEDURE

The Constitution requires the Scrutiny Committee to decide whether to consider the motion itself or refer it for consideration by a task group. Any task group so appointed will report back to the Committee. Once the Committee has considered the motion, or received a report back from a task group, it will report to the next available meeting of Cabinet.

Consideration of a motion might take the form of simply dealing with the motion without further scrutiny and reporting to Cabinet accordingly. If, however, the committee were to decide to consider the motion itself in more detail, any scrutiny would need to be supported by evidence that might not yet have been assembled.

### 3. NEWBOLD QUARRY PARK

Newbold Quarry is a local nature reserve that RBC manage in partnership with Warwickshire Wildlife Trust. When the site was opened in 2000 provision was made for a small disabled car park and stretch of tarmac footpath suitable for all abilities. However, the very topographical nature of the quarry means full DDA access is neither reasonable or practicable.

RBC work closely with the Rugby Disability Forum to identify areas for improvement on our open spaces in line with our strategic plans and have attended the site in the last year. They are consulted on all open space refurbishment projects. WWT Nature force undertake weekly volunteering activities along with a small group of local volunteers who undertake daily litter picks

The quarry is a high-risk water site and can attract substantial ASB which creates significant tensions for local residents. Both ourselves, the police and fire service are constantly trying to discourage use of the site. If someone got into difficulty in the water, there is a high risk of death. For this reason, we have annual independent water safety checks undertaken.

Alongside this RBC are engaged with a geological expert with regards the site.

Should funding become available then RBC would work with stakeholders and volunteers to make any suitable improvements identified.
