(a) demolition of existing bridge 24 and regrading of ground level to create a crossroad in conjunction with disused railway tracks/PROW at Bridge 24, Fields Farm Lane, Marton, Rugby, CV23 9RS (R20/0566) - Councillor Gillias moved and Councillor Sandison seconded that the Chief Officer for Growth and

Investment be authorised to grant planning permission subject to conditions and informatives set out in the report together with condition 4 being amended to read, "No works or development shall take place until a specification of all proposed tree planting has been approved in writing by the LPA. This specification will include details of the quantity, size, species, position and the proposed time of planting of all trees to be planted, together with an indication of how they integrate with the proposal in the long term with regard to their mature size and anticipated routine maintenance. In addition all shrubs and hedges to be planted that are intended to achieve a significant size and presence in the landscape should be similarly specified. If within a period of 10 years from the date of planting of any tree/shrub/hedge that tree/shrub/hedge, or any tree/shrub/hedge planted in replacement for it, is removed, uprooted, destroyed or dies, (or becomes in the opinion of the LPA seriously damaged or defective), another tree/shrub/hedge of the same species and size originally planted shall be planted at the same place, unless the LPA gives its written consent to any variations. Development shall be carried out in compliance with the approved specification."

In the interests of biodiversity and visual amenity."
