76. APOLOGIES FOR ABSENCE

Apologies for absence from the meeting were received from Councillors Leigh Hunt and Pacey-Day.

77. MINUTES

The minutes of the special meeting held on 2 February 2021 were approved.

78. MAYOR'S ANNOUNCEMENTS

- (i) It was with great sadness that the Council learned over the weekend that one of its colleagues had passed away. Keith Appleton worked for Rugby Borough Council for 39 years and was a valued member of the Revenues team. He would be missed greatly. All Members' and officers' thoughts were with Keith's wife and daughter, his colleagues and wider friends and family at this time.
 - All Members and officers present at the meeting joined the Mayor in a moment's silence in memory of Keith.
- (ii) With the government's publication of the road map to the end of restrictions there was renewed hoped that the pandemic would finally be over later this year. The promise of normality depended on beating the Covid-19 virus. Part of that was making sure that we all take up the offer of a vaccine when it is offered, but for now case numbers were still too high. The Mayor urged all residents to continue to take great care to wash their hands, keep their distance from one another and wear a mask. Soon we would be able to live life normally again, but we must remain patient and keep going until that time comes.

79. QUESTIONS PURSUANT TO STANDING ORDER 10

A. Councillor Douglas asked the following question of the Communities and Homes Portfolio Holder, Councillor Mrs Crane:

Recent research shows that one in five secondary school children may be a young carer. Caring for someone can be very isolating, worrying and

stressful. Each year, The Carers Trust has organised a Young Carers' Action Awareness Day. This year it will be renamed Young Carers' Action Day and will take place on Tuesday 16 March 2021. Will Rugby Borough Council commit to promoting the day and help raise public awareness of the challenges faced by young people and young adults because of their caring responsibilities?

Councillor Mrs Crane, Communities and Homes Portfolio Holder, replied as follows:

I'd like to thank Cllr Douglas for his question, which gives us all the opportunity to place on record our appreciation and admiration for the work young carers do in our communities every day.

Nationally, one in five young people find themselves taking on the role of carer for loved ones, from looking after brothers and sisters and carrying out household chores to managing the family budget and giving medicine to a parent.

It is a demanding role which can present young carers with many challenges – missing school, social isolation, and both mental and physical health problems.

And the pandemic has proved particularly challenging for these young people, who so often put the needs of others ahead of their own.

Young Carers Action Day highlights the amazing work these young people do and aims to raise awareness of the challenges young carers face. Young carers themselves have chosen the theme of this year's Action Day – Protect Young Carers' Futures.

The theme promotes the skills young people develop through being a carer – skills such as resilience, time-management and empathy. Skills which can flourish in higher education or the workplace, given the appropriate support and encouragement.

As a council, we fully support the aims of Young Carers Action Day and the work of charities such as Warwickshire Young Carers.

Last year, the Mayor of Rugby welcomed young carers from the borough to the Mayor's Parlour to mark Young Carers Awareness Day, and the education and outreach team at Rugby Art Gallery and Museum has forged a partnership with Warwickshire Young Carers, holding the first of a planned series of special visitor sessions for the charity's members before the pandemic and distributing activity packs and art materials to young carers during lockdown.

As a council, we're committed to supporting Young Carers Action Day on 16 March and plan to promote the event on our social media channels, signposting residents to the online support and resources available on the Carers Trust website.

Councillor Douglas then asked the Portfolio Holder if she could provide an assurance that partnership working to support young carers would continue to grow, which Councillor Crane was happy to provide.

B. Councillor Douglas asked the following question of the Environment and Public Realm Portfolio Holder, Councillor Roberts:

Does Rugby Borough Council record graffiti reported to the Council each year and how much is it costing to remove graffiti annually?

Councillor Roberts, Environment and Public Realm Portfolio Holder, replied as follows:

The Council records all reports of graffiti received. Whilst the specific costs of removing graffiti are not recorded, an indicative figure can be provided to Councillor Douglas, if it would be helpful.

Councillor Douglas then asked the Portfolio Holder if he would establish a Task Group to address the issue of graffiti in the borough and to look to provide support to businesses to tackle this problem. Councillor Roberts informed Councillor Douglas that the Council's working party on flytipping would be dealing with this issue but was happy to discuss this with him separately.

Add in new separate organisational commitment

We will reduce the carbon footprint of our council housing stock by 2027.

Outcome 2 - Economy

Introduction to be amended to read, "Rugby has a diverse and resilient economy that benefits *and enables opportunities for all* residents."

Outcome 3 - Health & Communities

Add the following two organisational commitments:

- Invest in the mental health and wellbeing of our residents and communities, closing the health inequality gap
- Invest in extra support for families and young people

Further to discussion, the Mayor put the amendment to the vote and declared it carried.

A vote was then taken on the substantive motion and was declared carried.

84. NOTICES OF MOTION UNDER STANDING ORDER 11

Council considered the following Motions, notice of which had been given pursuant to Standing Order 11.

The Mayor considered it advisable and convenient to deal with the motion at item 8(a) of the agenda at the meeting.

Councillor Mrs Brown moved and Councillor Mistry seconded the motion as set out below.

"The £20 weekly boost to Universal Credit is a lifeline that is keeping many individuals and families in Rugby afloat at this difficult time. The pandemic has caused immense economic pressure to those on a low income, and if the £20 boost is withdrawn these people will sink below the poverty line.

Because of the continuing and unprecedented economic pressure that Covid has caused for some of our residents, we urge Rugby Borough Council to write to Central Government to demand that the £20 weekly boost to Universal Credit payment is retained."

Further to debate, the Mayor put the motion to the vote and declared it carried.

Councillor Ms Robbins moved and Councillor Poole seconded the following motion as set out at item 8(b) of the agenda.

"This council recognises the increase in flooding in the Borough and the probability that this will continue to increase in severity as global warming and rainfall become more prevalent. It is essential that new build homes and local facilities are protected from future flooding and that flood plains are developed to cope with the increase. This is demonstrated by the facilities at the Elliotts Field shopping centre and the good use of the car park to accommodate flooding from the River Avon and the River Swift.

We ask that this issue is reviewed by the Scrutiny Committee, looking at the way in which flooding in the Borough is managed and how this can be improved. A report then be brought to Cabinet and Council for consideration."

Further to the proposer and seconder speaking and in accordance with paragraph 11.2(d) of Council Standing Orders, the motion stood referred to Scrutiny Committee.

The Mayor considered it advisable and convenient to deal with the motion at item 8(c) of the agenda at the meeting.

Councillor Mrs Allanach moved and Councillor Miss Dumbleton seconded the motion as set out below.

"Covid 19 has had a major negative impact on people's health, wealth and wellbeing throughout the world. In response to the pandemic, our national government has begun the roll out of vaccination and testing centres throughout England.

With the exception of the two hospital sites in the county, the Rugby centre has delivered more vaccines than any other in Warwickshire "(Rugby Advertiser 21.01.2021). In addition, the feedback from individuals who have attended both Locke House, and the testing centre in Edward Street is extremely complimentary, with many commenting on the professionalism of the staff and volunteers, the Covid security of the facilities and how well organised everything was.

This motion calls for the Council to formally acknowledge the excellent progress our local vaccination centre, Locke House, and the testing centre, have made by recording a sincere thank you to all concerned. When so much of the news around Covid 19 is not good, we feel that such positive news should be celebrated."
