10. MINUTES

At the meeting, the following representative attended under the Council's public speaking procedure in respect of the following application.

(i) R17/0971 Former Gala Bingo Site, Evreux Way, Rugby

In accordance with Council procedure, Councillor Mrs New left the meeting once all presentations had been made and was not present for the debate.

RESOLVED THAT - the Head of Growth and Investment be authorised to issue a decision notice as indicated in relation to the application below.

(a) erection of two storey drive through restaurant and associated works at former Gala Bingo site, Evreux Way, Rugby (R17/0971) – Councillor Sandison moved and Councillor Roodhouse seconded that the Head of Growth and Investment be authorised to refuse planning permission for the following reasons.

It was considered that the proposed development would be detrimental to the economic sustainability, detract from the vitality, and fail to support a prosperous town centre and, as such, conflict with Policy TC1. It was also considered that the proposal conflicted with Policy HS5 due to the detrimental impact on the air quality within the town centre as it would fail to achieve or exceed air quality neutral standards.

Further to debate, Councillor Cranham moved and Councillor Butlin seconded that the Head of Growth and Investment be authorised to grant planning permission subject to the conditions in the report together with the following conditions being amended to read:

CONDITION: 9

Unless non-material variations are agreed in writing with the Local Planning Authority the premises shall not be opened for business other than between the hours of 06.00 to 23.00.

CONDITION: 12

No part of the development herby permitted shall be first brought into use as a drive through restaurant unless and until a delivery and servicing strategy, which identifies the location and timings of deliveries, which shall not occur between the hours of 07.00 and 21.00, within the perimeter of the development site has been submitted and approved in writing by the Local Planning Authority. The deliveries to the site and servicing of the site shall not be carried out other than in accordance with the approved details.

Conditions 13, 14, 15 and 17 be amended to refer to "first brought into use as a drive through restaurant" instead of "occupied".

Further to discussion, 3 members requested a recorded vote under Standing Order 3A Paragraph 15.4 on the proposed amendment for refusal of the application.

For the motion – Councillors Mrs Brown, Brown, Ellis, Roodhouse and Sandison – **5 votes**

Against the motion – Councillors Bearne, Butlin, Cranham, Gillias, Pacey-Day, Picker and Mrs Timms – **7 votes**

The Chairman declared the amendment lost.

Against the motion – Councillors Mrs Brown, Brown, Ellis, Roodhouse and Sandison – **5 votes**

CONDITION: 12

No part of the development herby permitted shall be first brought into use as a drive through restaurant unless and until a delivery and servicing strategy, which identifies the location and timings of deliveries, which shall not occur between the hours of 07.00 and 21.00, within the perimeter of the development site has been submitted and approved in writing by the Local Planning Authority. The deliveries to the site and servicing of the site shall not be carried out other than in accordance with the approved details.
